In October, PABA members enjoyed “A Real Breakfast of Champions”. WPS hosted this breakfast to celebrate Plover’s successful participation in the iCanConserve program. Plover reached an astounding 66% participation (109% of goal) in the pilot project. The Village of Plover received a magnificent community reward of \$25,000 in free LED lighting upgrades. The iCanConserve project started in July 2011 in the Village of Plover. Since its launch, thousands of Plover residents and business owners have seen a significant reduction in their energy costs by enrolling in the program and taking advantage of the energy audits conducted by Focus on Energy. November Luncheon



A luncheon, sponsored by Compass Insurance Services, was held at the Silver Coach in November which included a presentation regarding the Affordable Care Act (ACA) and how it will impact you and your business. Bryan Troyer, Vice President of the Benefits Division at Compass Insurance Services, and Attorney Mary Ellen Schill from Ruder Ware provided an overview of the key ACA provisions. The new act will require insurers to make dependent coverage available up to age 26, will prohibit lifetime limits on “essential benefits” and pre-existing condition exclusions, and will require W-2 reporting for companies with greater than 250 employees. Many changes are happening now and will continue to happen into 2014.
